

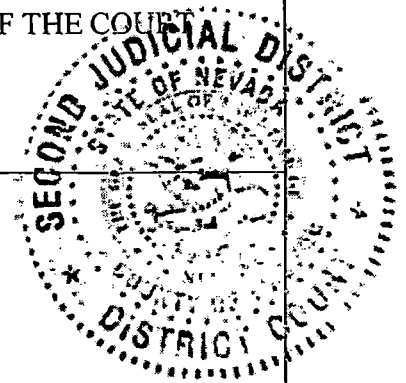

8 affirm I will follow the Protected Person's Bill of Rights to the greatest extent possible.


