20 **IT IS HEREBY ORDERED that the Magistrate's Findings and Recommendations are affirmed and adopted.**

21 **IT IS THEREFORE ORDERED AS FOLLOWS:**

23 1. (x) The Obligor is the parent of the following children:

27 2. (x) A Judgment is entered against Obligor for child support arrears in the
28 amount of \$6,439.90 from November 1, 2022 through March 31, 2023. A
Judgment is entered against Obligor for interest on child support arrears in

1 the amount of \$0.00 from November 1, 2022 through March 31, 2023. A
2 Judgment is entered against Obligor for penalties on child support arrears in
3 the amount of \$0.00 from November 1, 2022 through March 31, 2023. This
4 shall be paid at \$100.00 per month starting April 1, 2023 until paid in full.

- 5 3. (x) The Obligor shall pay \$1,287.78 per month in ongoing support beginning
6 April 1, 2023 and on the same day each month thereafter until further order
7 of this Court.
- 8 4. (x) The Obligor shall pay \$0.00 per month in ongoing medical cash support
9 beginning April 1, 2023 and on the same day each month thereafter until
10 further order of this Court.

11 **All payments MUST be in the form of a cashier's check or money order ONLY.**
12 **Effective August 1, 2000, all child support payments must be payable to State**
13 **Collection and Disbursement Unit (SCaDU) and mailed to: SCaDU, P.O. Box 98950,**
14 **Las Vegas, NV 89193-8950.**

15 **NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY TO**
16 **THE OBLIGEE OR THE CHILD.**

17 **Additionally, the Obligor MUST place his social security number on each payment.**

18 **Effective January 1, 2004, simple interest will accrue on all unpaid child support**
19 **balances for cases with a Nevada controlling order pursuant to NRS 99.040. Interest**
20 **assessed by a judgment of the court prior to January 1, 2004 will be enforced.**

21 **If you pay your child support through income withholding and your full obligation**
22 **is not met by the amount withheld by your employer, you are responsible to pay the**
23 **difference between your court ordered obligation and the amount withheld by your**
24 **employer directly to the state disbursement unit. If you fail to do so you will be**
25 **subject to the assessment of interest.**

26 **YOU MAY AVOID THESE ADDITIONAL COSTS BY MAKING YOUR CURRENT CHILD**
27 **SUPPORT PAYMENTS EACH MONTH.**

- 28 5. (x) The Obligor shall provide health insurance, including medical, dental,
orthodontic and ophthalmological coverage for the child if available through
her employment at a reasonable cost, including any group health plan(s)
under ERISA, from the date of this order on and until said child is no longer
eligible for said coverage, and both parties shall cooperate and provide
assistance in obtaining payment for health care services. You are required
to notify the Child Support Enforcement Office when health insurance
coverage is available or has been terminated.



6. (x) The Obligor and Obligor shall pay health care expenses, including medical,
dental, orthodontic, and ophthalmological services for the child as follows:
one half of all costs not covered by insurance, upon being provided by

expenses and any EOB or other insurance payment documentation.

- 7. (x) The Obligor shall notify the State Child Support Office or the District Attorney's Child Support Office of any change of address or employment within ten (10) days.
- 8. (x) A wage/income withholding shall be issued starting immediately.
- 9. Pursuant to NRS 125B.145 this Order may be reviewed every three (3) years and is subject to future modifications.
- 10. Unless a stay of this Order is obtained from District Court, all enforcement procedures including, but not limited to wage withholding, garnishment, liens and the attachment of federal income tax returns will be undertaken upon entry of this Order.
- 11. If any determination of paternity in this Order is at variance with the child's birth certificate issued in this state, a new birth certificate is to be issued pursuant to NRS 440.325.
- 12. The parties shall fill out the attached Court Information Sheet and mail the same to the Nevada State Welfare Division Child Support Enforcement, 3120 East Desert Inn Road, Las Vegas, NV 89121-3857 for filing with the court within ten (10) days from the date of this Order. The parties shall update this form within ten (10) days of it becoming inaccurate.
