BE IT KNOWN that THE ROMAN CATHOLIC ARCHBISHOP OF LAS VEGAS, AND HIS SUCCESSORS, A CORPORATION SOLE, formerly The Roman Catholic Bishop of Las Vegas and His Successors, a corporation sole prior to its elevation to an Archdiocese by His Holiness Pope Francis, by and through The Most Reverend George Leo Thomas, Ph.D., formerly Bishop and now Archbishop, as Incumbent/Principal of The Roman Catholic Archbishop of Las Vegas and His Successors, a corporation sole does hereby constitute, appoint and designate:

as Attorney-in-Fact.

This Power of Attorney revokes and supersedes the Power of Attorney given to Most Reverend Gregory W. Gordon executed on May 24, 2022 by the then Roman Catholic Bishop of Las Vegas, and His Successors, a corporation sole.

Subject to the below limitations, I confer upon my Attorney-in-Fact the full authority to act on behalf of The Roman Catholic Archbishop and His Successors, a corporation sole (hereinafter "Principal"), to perform the acts or powers I have designated below as I could do if personally present, in my name, in my stead and for the benefit of the Roman Catholic Archbishop of Las Vegas and His Successors, a corporation sole. Having the full authority and power of substitution and revocation I do hereby ratify and confirm all acts that may lawfully be done in pursuance of the powers and actions authorized by this Power of Attorney.

Notwithstanding anything else herein, this Power of Attorney does not permit Most Reverend Gregory W. Gordon as my Attorney-in-Fact to:

- A. Acquire or sell real property or any interests therein, which is now or hereafter acquired by, or in which an interest is acquired by, the Incumbent/Principal in excess of \$250,000 unless the dual signature of a second Attorney-in-Fact is included in which case such acquisition, sale or transfer of any interest in real property may not exceed \$500,000; or
- B. Do any other act which would make it impossible to carry on the ordinary business of the Archdiocese.
