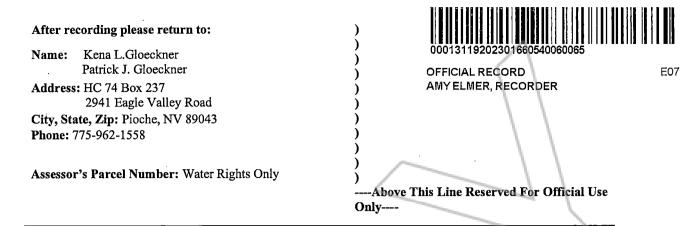

WATER RIGHTS QUITCLAIM DEED

THIS INDENTURE WITNESSETH:

That the GRANTORS: TONA LYTLE, KENA LYTLE GLOECKNER, and LYNN LLOYD, each individually and as co-trustees of the Kenneth E. Lytle and Donna B. Lytle Living Trust, for valuable consideration the receipt of which is hereby acknowledged, does hereby grant to the GRANTEES: Kena Lytle Gloeckner and Patrick J. Gloeckner, husband and wife as joint tenants with full right of survivorship, all its right, title and interest in the following:

- (1) All interest in water rights owned, held, claimed, and/or used by Kenneth E. Lytle, by Donna B. Lytle, by their predecessors and/or by Kenneth E. Lytle and Donna B. Lytle Living Trust, including but not limited to water rights listed in Quit Claim Deed Executed on November 7, 2011, and recorded as document number 0139831, book 267, page 0545, which transfers certain water rights to Kena Lytle Gloeckner and Patrick Gloeckner. Also, including but not limited to, all interest in existing water right applications, permits, certificates, and/or proofs of appropriation subject to adjudication, on file with the Nevada Division of Water Resources.
- (2) All interest in Eagle Valley Irrigation Company (EVIC) water shares owned, claimed and/or held by Kenneth E. Lytle, by Donna B. Lytle, by their predecessors and/or by the Kenneth E. Lytle and Donna B. Lytle Living Trust.
- (3) Grantors grant to Arthur Mick Lloyd and Lynn Lloyd, husband and wife, as joint tenants, access to and the ability to use the water associated with the stock water rights for cattle owned only by Arthur Mick Lloyd and Lynn Lloyd and or their direct lineal descendants within the Wilson Creek Allotment to be utilized pursuant to the Wilson Creek Allotment governing documents. By this grant of access to and ability to use the water associated with the stock water rights for cattle, no ownership interest or other incidents of title are being granted for the stock water rights and all incidents of title to the water rights are expressly reserved to Kena Gloeckner and Patrick Gloeckner.

TONA LYTLE and LYNN LLOYD, individually, further hereby assign any and all interest they may have in the stock water rights and EVIC water shares deeded hereby as an heir of Kenneth E. Lytle, Donna B. Lytle, their predecessors in interest, and/or the Kenneth E. Lytle and Donna B. Lytle Living Trust, to Kena Lytle Gloeckner and Patrick J. Gloeckner, husband and wife as joint tenants with full right of survivorship.

TO HAVE AND TO HOLD, all and singular and tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the remainder and remainders, reversion and reversions, rents, issues and profits thereof unto the said Grantee, and to its successors and assigns forever.

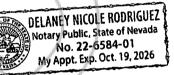
