JUDGMENT OF CONVICTION

WHEREAS, on February 25, 2022, the above-named Defendant, KIM A. JUDD, further described as: Date of Birth: 12/21/1958; Place of Birth: Utah, entered a plea of not guilty to the crimes of COUNT I - INJURING OR TAMPERING WITH A MOTOR VEHICLE, a violation of NRS 205.274(1) and NRS 193.155(1), a Category C Felony, and COUNT II - COERCION, a violation of NRS 207.190, a Category B Felony, as alleged in the Criminal Information filed before this Court; and

WHEREAS, the matter came before a jury on August 16-18; 2022. The Defendant was present and represented by counsel, FRANKLIN J. KATSCHKE, Esq., Lincoln County Public Defender. The State was present and represented by DYLAN V. FREHNER, Esq., Lincoln County District Attorney. The jury found the Defendant guilty of COUNT I - INJURING OR TAMPERING WITH A MOTOR VEHICLE, a violation of NRS 205.274(1) and NRS 193.155(1), a Category C Felony, and COUNT II - COERCION, a violation of NRS 207.190, a Category B Felony.

WHEREAS, on November 18, 2022, the Defendant appeared in court with counsel,

FRANKLIN J. KATSCHKE, Esq., Lincoln County Public Defender, for sentencing. DYLAN V. FREHNER, Esq., Lincoln County District Attorney, was present representing the State and MELANIE BOYNTON was present representing the Nevada Division of Parole and Probation.

After hearing from all parties and allowing the Defendant an opportunity to personally address the Court, the Court adjudged the Defendant guilty thereof by virtue of said verdict to the crimes of COUNT I - INJURING OR TAMPERING WITH A MOTOR VEHICLE, a violation of NRS 205.274(1) and NRS 193.155(1), a Category C Felony, and COUNT II - COERCION, a violation of NRS 207.190, a Category B Felony. The Court found that the appropriate judgment in this case is as follows:

## SENTENCE TERMS

For the conviction of COUNT I - INJURING OR TAMPERING WITH A MOTOR VEHICLE, a violation of NRS 205.274(1) and NRS 193.155(1), a Category C Felony, the Defendant is sentenced to serve a maximum term of forty-eight (48) months in the Nevada Department of Corrections, with parole eligibility after a minimum term of nineteen (19) months.

For the conviction of COUNT II - COERCION, a violation of NRS 207.190, a Category B Felony, the Defendant is sentenced to serve a maximum term of forty-eight (48) months in the Nevada Department of Corrections, with parole eligibility after a minimum term of nineteen (19) months, concurrent with Count I.

IT IS HEREBY ORDERED that the Clerk of this court enter this Judgment of Conviction as part of the record in the above-entitled matter.

IT IS FURTHER ORDERED that the Defendant shall pay a Twenty-Five Dollar (\$25.00) Administrative Assessment Fee, a Three Dollar (\$3.00) Genetic Marker Analysis Fee, and a One Hundred Fifty Dollar (\$150.00) DNA Administrative Assessment Fee.

IT IS FURTHER ORDERED that the fees assessed shall be paid to the Lincoln County Clerk's Office, PO Box 90, Pioche, Nevada 89043.

IT IS FURTHER ORDERED that the Defendant shall pay restitution in the amount of Seventeen Thousand Five Hundred Ninety-four Dollars and Eighty Cents (\$17,594.80).

IT IS FURTHER ORDERED that the Defendant shall sign a civil confession of judgment in the amount of Seventeen Thousand Five Hundred Ninety-four Dollars and Eighty Cents (\$17,594.80) to Scott Reber.

IT IS FURTHER ORDERED that the Bond in this matter, if any, shall be exonerated.

IT IS FURTHER ORDERED that the Defendant shall remain in the custody of the Lincoln County Detention Center until further court order.

IT IS FURTHER ORDERED that this matter come back before this Court for a motion hearing on Thursday, December 15, 2022, at 10:00 a.m.
