

**NOTICE & CERTIFICATE OF LOCATION
LODE MINING CLAIM – NEVADA**

Located on the 11th day of October 2023.

The Lode Mining Claim is situated in the Unknown/ Unnamed Mining District, Nye and Lincoln Counties, State of Nevada.

The boundaries of the claim are marked by four substantial monuments, one at each corner of the claim. Said monuments consist of 1.5” x 1.5” wooden posts at least 4 feet in length set at a minimum of 1’ into the ground. Each monument is marked with a scribed metal tag which states the claim name and number and the location of the monument with respect to the claim. Further described as follows:


- Beginning at the northeast corner of the claim, post No. 1
- Thence 600 feet in a south direction to the southeast corner, post No. 2,
- Thence 1,500 feet in a west direction to the southwest corner, post No. 3,
- Thence 600 feet in a north direction to the northwest corner, post No. 4,
- Thence 1,500 feet in an east direction, returning to post No. 1.

The claim is approximately 1,500 feet long and 600 feet wide, such that 30 feet are claimed in a west direction and 1,470 feet in an east direction from the point of discovery, at which the Notice of Location was posted, together with 300 on each side of the monument of location and center line of the claim. The general course of the lode or vein is from the west to east direction.


To tie this claim to the Public Survey, begin at the NE corner Sec. 1, Township 1 North, Range 53 East, Mount Diablo Meridian; bear south approximately 2,700 feet and east approximately 16,885 feet to the Location Monument of this Claim. The claim is located in the following protracted quarter sections: **NW ¼ & SW ¼ Sec. 3, T1N, R54E, Mount Diablo Meridian.**
