## CERTIFICATE OF LOCATION

### Lode Mining Claim

NOTICE IS HEREBY GIVEN that **Globex Nevada, Inc.**, 86-14<sup>th</sup> Street Rouyn-Noranda, Quebec, J9X 2J1, Canada, hereby claims under and pursuant to the laws to the State of Nevada and of the United States of America the following described **LODE MINING CLAIM**.

The name of the claim is the FL-9.  
This claim was located on the 21<sup>st</sup> day of March 2024, by posting a Location Notice at the discovery monument.

The length of the claim is 1490 feet in a southerly direction and 10 feet in the opposite direction from the monument where the Notice of Location is posted, and the width is 300 feet on each side of the center of the vein or lode, comprising in all 1500 feet in length and 600 feet in width, and generally following a north-to-south course.

The exterior boundaries are distinctly marked by four substantial monuments. Each corner monument consists of a 1.5" x 1.5" x 4' wooden post with an aluminum tag attached, scribed with the claim name and corner description, set one foot in the ground. The boundaries can be readily traced by beginning at corner No. 1, the northwestern-most corner:

Thence 1500 feet South to the southeastern corner, corner No. 3,  
Thence 600 feet West to the southwestern corner, corner No. 4,  
Thence 1500 feet North to the northwestern corner, corner No. 1, the point of beginning.
