SUBORDINATION AGREEMENT

STATE OF NEVADA COUNTY OF LINCOLN

THIS AGREEMENT made and entered into this /2 day of _______, 20 24. by and between NEVADA HOUSING DIVISON ("Subordinating Lender") and NEWREZ LLC ("New Lender");

WITNESSETH:

THAT WHEREAS, by Deed of Trust dated 9/6/2023, in the principal amount of \$25,000.00, recorded 9/7/2023 in Instrument No. 2023-165936 in the Official Records of LINCOLN County Recorder's Office (the "Existing Deed of Trust"), Executed by LESLIE PHILLIPS AND GARY B. PHILLIPS, WIFE AND HUSBAND AS JOINT TENANTS (Grantor/Mortgagor) conveyed to FIRST AMERICAN TITLE as Trustee(s) for NEVADA HOUSING DIVISON, real estate located in LINCOLN County, Nevada as more particularly described in said Existing Deed of Trust, to secure certain indebtedness therein set out;

WHEREAS, Subordinating Lender is the sole holder and owner of the indebtedness secured by the Existing Deed of Trust; and

WHEREAS, New Lender has agreed to lend the Borrower a sum not to exceed \$197,250.00, said loan to be secured by a deed of trust upon condition that said Existing Deed of Trust to be subordinated to the lien of New Lender's deed of trust; and

It is expressly understood and agreed that except for such subordination, the Existing Deed of Trust now held by Subordinating Lender and all and singular the terms and conditions thereof shall be and remain in full force and effect.


