MEMORANDUM OF AGREEMENT

BY THIS MEMORANDUM OF AGREEMENT ("Memorandum") notice is hereby given regarding that certain Mineral Exploration Lease and Option to Purchase (the "Agreement") made and entered into as of February 10, 2023 and as amended by that certain First Amendment to Mineral Exploration Lease and Option to Purchase, dated March /8, 2024 (the "Amendment Date"), by and between PRINCE MINE, LLC, a Nevada limited liability company, whose address is HC 74, Box 150, Pioche NV 89043 ("Owner") and STAMPEDE METALS CORPORATION, a Nevada corporation, with an address of 12600 W Mile Wide Rd, Marana AZ 85653 ("Stampede"). Owner and Stampede desire to confirm the Agreement and place on record a notice of the Agreement as follows:

- 1. The Prince Mine. The Agreement regards 12 patented lode mining claims with non-severed surface and mineral rights that cover approximately 227 acres in Lincoln County NV as more particularly described in Exhibit "A" attached hereto and incorporated herein by reference (the "Prince Mine").
- 2. Lease: Owner has agreed to and hereby does lease ("Lease") exclusively to Stampede the Prince Mine, other than the surface of the south half of the Bullion Belcher No. 1 Claim as that claim would be equally divided by a line perpendicular to the eastern long boundary of such claim, (the "Leasehold") together with certain rights, among others, to take and develop groundwater and related facilities, and subject only to certain limitations, all as more particularly described in the Agreement. Under the Lease, Stampede may enter and occupy the Leasehold for mineral exploration, evaluation of project feasibility, related environmental remediation and other purposes as set forth in the Agreement. The term of the Lease shall commence on March 31, 2023 and continue for 8 years unless terminated, extended or canceled as provided in the Agreement.
- **3. Options:** Owner has granted 2 options (the "<u>Options</u>") to Stampede to acquire all or part of the fee interest and all appurtenant rights in the Prince Mine, such Options to have terms as more particularly described in the Agreement.

Each of Owner and Stampede retain copies of the Agreement on file. The Agreement contains terms and conditions that are not set forth in this Memorandum but which nevertheless are by reference made a part hereof. If there is a conflict between the terms of this Memorandum and the terms of the Agreement, the terms of the Agreement shall control in all respects. This Memorandum has been executed and recorded to provide public notice of the Agreement and not to modify or qualify any of the terms of the Agreement.


