17 The Court, having reviewed the verified *Petition for Appointment Of Administrators With Full*
18 *Authority to Administer the Estate Under the Independent Administration of Estates Act, and For*
19 *Issuance of Letters of Co-Administration* (the "Petition") filed by Petitioners RYAN A. HOOVER
20 and CHERYL PARKER, by and through their counsel the Law Firm of Jeffrey Burr, LTD.; having
21 set a hearing thereon for March 22, 2024 at 1:00 p.m.; having received no objection to the Petition;
22 and having examined the evidence and being fully advised in the premises, finds: (i) proper notice of
23 the hearing was duly given as required by law; (ii) the facts alleged in the Petition are true and correct;
24 (iii) REED A. HOOVER, aka REED HOOVER, died on November 3, 2023, in Lincoln County,
25 Nevada, and was at the date of his death a resident of Lincoln County, Nevada; (iv) Petitioners are
26 qualified to serve as Administrators of the Estate; (v) the gross value of the Estate of the Decedent is
27 in excess of \$300,000.00; and (vi) the Petition should be granted.

28 Good cause appearing, it is hereby

1 **IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** that:

2 1. The Decedent died intestate; and

3 2. RYAN A. HOOVER and CHERYL PARKER, are hereby appointed as Co-
4 Administrators of the Decedent's Estate and that Letters of Co-Administration issue to RYAN A.
5 HOOVER and CHERYL PARKER, upon them taking the oath as required by law; and

6 3. The Co-Administrators be authorized to administer the Estate of the Decedent under
7 the Independent Administration of Estates Act with full authority; and

8 4. The Estate consists of property with a value that does exceed THREE HUNDRED
9 THOUSAND DOLLARS (\$300,000.00);


10 5. General administration is hereby ordered; and

11 6. Bond is hereby waived, however, if any funds are received by the estate, they are to
12 be held in the JEFFREY BURR LTD. CLIENT TRUST ACCOUNT for the benefit of the estate of
13 REED A. HOOVER, aka REED HOOVER.
